

2019/2020 TAX REQUEST RESOLUTION
FOR DAKOTA COUNTY SCHOOL DISTRICT 31R

WHEREAS, public notice was given at least five days in advance of a Special Public Hearing called for the purpose of discussing and approving or modifying the District's Tax Requests for the 2019/2020 school fiscal year for the General Fund and Special Building Fund of Dakota County School District 31R; and,

WHEREAS, such Special Public Hearing was held before the Board of Education (hereinafter "the Board") of Dakota County School District 31R (hereinafter "the District" at the time, date, and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication of which is attached hereto as Exhibit A, all as required by law; and,

WHEREAS, the Board provided an opportunity to receive comment, information and evidence from persons in attendance at such Special Hearing; and

WHEREAS, the Board, after having reviewed the District's Tax Requests for each said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2019/2020 school fiscal year.

NOW BE IT THEREFORE RESOLVED that the Homer Community School District Board of Education will levy


1. \$3,844,444 in property taxes (**a \$91,919 decrease in property tax asking from 2018 – 19**).
2. The total assessed value of property is 4.27 percent less than 2018 – 19 (402,435,791 in 2018-19 and 385,234,761 in 2019- 20).
3. The tax rate which would levy the same amount of property taxes as last year when multiplied by the new total assessed value of property would be \$1.021809 per \$100 of assessed valuation (\$3,936,363 taxes divided by \$385,234,761 in valuation).
4. The district proposes to adopt a property tax request that will cause its tax rate to be \$.997948 per \$100 of assessed value; and
5. Based on the proposed property tax request and changes other revenue, the total operating budget of the district will be exceed the 2018-19 budget by 1%.
